RULES & REGULATIONS

Welcome to the 4th annual Fulton Farms Sweetcorn Festival. The Festival will be held August 26th and 27th, 2017.

Set up for the festival is Friday, August 25th, from 3:00–8:00pm and also on Saturday morning from 8:00–10:00am.

For all Food Vendors, the cost of your application fee to reserve a spot at the festival is \$200.

For all Craft Vendors, the cost of your application fee to reserve a 12x12 spot at the festival is \$75.

The following rules have been established in order to create a family friendly festival. Read the rules and regulations and keep this copy for your records. Failure to observe these rules may result in termination of your festival reservation.

Individual vendors will be responsible for adhering to product labeling regulations, and conforming to applicable city, state, and federal laws including the securing of any licenses required for the operation of your festival space.

All Vendors are required to carry a minimum of \$100,000 liability insurance. Proof of insurance is required as a part of the application.

Complete the application legibly and completely even if you have attended before, also complete the hold harmless agreement, and include a copy of your proof of insurance.

Applications are due by July 31st.

RULES OF OPERATION

Prices for all vendor' s items must be clearly posted.

Operate your stand in a safe, sanitary, neat manner. Keep sales area (including ground) clear of garbage. Remove all of your garbage when you leave each day. If you are offering samples and handing out napkins, plates, cups, ect. Please provide a trash can for your customers.

All vendors must register with Fulton Farms. You will not be allowed to set up at the festival until your registration has been approved. Submitting an application does not automatically mean you are approved for the festival. *You will receive notification of your acceptance from Fulton Farms Sweetcorn Festival Management.*

A standard booth size is 12' x12' .

Assignments will be based on available market space, the need for a specific product, and the number of spaces you require. Please specify on your application if you need access to an electricity hook-up.

The display or sale of any merchandise that is illegal, undesirable, or inappropriate for a family-orientated festival is strictly prohibited. Any attempt to sell merchandise other than represented by the application may result in removal from the festival.

Pet policy for the consideration and safety of the farm animals on the festival grounds all pets are prohibited.

There is no early teardown of booths permitted

Booths must be manned at all times during festival hours.

If there is a significant weather event expected, vendors will be alerted/notified by farm staff.

VENDOR SAFETY REQUIREMENTS

All Vendors must have their tents securely anchored with the appropriate anchors and straps.

Any exposed rebar or tent stakes that are exposed must be protected to prevent accidental injury.

Approved cooking devices that employ gas, electric, charcoal, or wood that limit the flame height to a maximum of six inches shall only be permitted under an open sided (no side material present) tent. The tent material shall be fire retardant and at least five feet above the cooking surface.

All electrical and mechanical equipment shall be kept in good working condition in order to not present a fire or electrical hazard.

Food Vendors shall be equipped with an approved and appropriate type of fire extinguisher. All cooking booths shall have a minimum 3ft clear aisle on each side.

The use of extension cords should be kept to a minimum. The cords shall be listed for outdoor use, and kept free from damage from vehicles and pedestrians.
